2	To enact R.S. 24:35.2 and to repeal R.S. 24:35.5, relative to redistricting; to provide for the
3	election districts for the House of Representatives of the Legislature of Louisiana;
4	to provide for effectiveness; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 24:35.2 is hereby enacted to read as follows:
7	<u>§35.2.</u> Membership of the House of Representatives
8	The House of Representatives of the Legislature of Louisiana shall be
9	composed of one hundred five members. The state shall be divided into the
10	representative districts provided in this Section. One representative shall be elected
11	from each district.
