# DEPARTMENT ORGANIZATION

### Article IV, Section 8 of the Constitution of Louisiana

There shall be a Department of Justice, headed by the attorney general, who shall be the chief legal officer of the state...

As necessary for the assertion or protection of any right or interest of the state, the attorney general shall have authority (1) to institute, prosecute, or intervene in any civil action or proceeding; (2) upon the written request of a district attorney, to advise and assist in the prosecution of any criminal case; and (3) for cause, when authorized by the court which would have original jurisdiction and subject to judicial review, (a) to institute, prosecute, or intervene in any criminal action or proceeding, or (b) to supersede any attorney representing the state in any civil or criminal action.

### Article X, Section 2

The unclassified civil service shall include employees, deputies, and officers of the office of the attorney general.

### DEPARTMENT FUNCTIONS

#### Administrative \$7.6 Million

Contains the Executive Office and Administrative Services. Includes the collections section, which collects defaulted student loans and assists 11 boards, agencies, and commissions on collections.

#### Civil Law \$23.3 Million

Contains the Civil Division and the Public Protection Division. Includes attorneys assigned to various state departments, defense of state agencies in civil claims, writing legal opinions, and enforcement of the Tobacco Master Settlement agreement.

#### Criminal Law and Medicaid Fraud \$16.3 Million

Conducts or assists in criminal prosecutions; provides legal services; operates White Collar Crimes Section, Violent Crime and Drug Unit, Medicaid Fraud Control Unit, High Tech Crimes Unit, the Investigations Section, and the Sexual Predator Apprehension Team.


#### Risk Litigation \$18.9 Million

Provides legal representation for the state in civil rights, general liability, medical malpractice, road hazards, workers' compensation, and representation of the judicial branch. Funding comes from Interagency Transfers from the Office of Risk Management.

#### Gaming \$6.8 Million

Provides representation to the La. Gaming Control Board, the La. Lottery Corporation, the State Racing Commission, state police and the Dept. of Revenue. Funding is from statutory dedications, interagency transfers, and fees.

### MAJOR SOURCES OF FUNDING

### Self Generated Revenue \$6.8 M

- \$6.6 million is in the Civil Law Program from consumer/antitrust settlements, Unfair Trade Practices Act penalties, and fees charged for legal services for quasi-state agencies.
- \$112K is from participation in the US Dept. of Justice Federal Forfeiture Program.
- \$112K is from the LA Lottery Commission.

### Statutory Dedications \$17 M

- \$1.6 Million is from the Dept. of Justice Legal Support Fund and \$2.5 million is from the Debt Collection Fund, which receive a portion of proceeds from lawsuits and collections.
- \$6.3 million in the Gaming Program.
- \$1.9 Million is from a fund for Medicaid Fraud detection.
- \$400,000 from the Tobacco Settlement Enforcement fund to the Civil division for the enforcement of the Master Settlement

### Interagency Transfers \$24 M

- \$18.9 Million is from the Office of Risk Management for the Risk Litigation Program.
- \$4 Million is for the Civil Law Program from various state agencies for legal services and from the LA Commission on Law Enforcement for safe schools and domestic violence training.
- \$1.2 Million is for the Criminal Law and Medicaid Fraud and Gaming Programs from various state agencies for investigative and legal services.

### Federal Funding \$7.5 M

- \$6.9 Million is from the US Medicaid Fraud Unit and the US Dept. of Justice.
- \$316K is from a grant for Internet Crimes Against Children
- \$108K is from the US Dept. of Housing and Urban Development for administration of the Louisiana open housing law.

Increases are to the Criminal Law and Medicaid Fraud Program from the Department of Health and Human Services Medicaid Fraud Unit and the U.S. Department of Justice

# SIGNIFICANT EXPENDITURE CHANGES

### Personal Services - \$3 million

Decrease for loss of 4 positions and attrition offset by increases in salary base adjustment, related benefit adjustment, and retirement adjustments.


### Professional Services - (\$928,897)

Reduction is primarily in the Civil Law Program for contract legal services including expert witnesses and there is an increase in funding for Louisiana tax stamp data services.

### Acquisitions and Major Repairs- (\$1.6 Million)

Reduction is due to a realignment of funds into professional services as there is no longer a need for purchasing Louisiana tax stamp data equipment as they are outsourcing the services.

### DOJ FY 19 EXPENDITURE TREND




Analysis shows approximately \$10.3 million or 14% in total means of finance budget authority could be unspent at year-end based on actuals through February and projections through the end of the year.

For FY 18, the DOJ had \$12.4M or 16.8% of unspent budget authority.

Last year 47% of DOJ's remaining authority was interagency transfers. Using this percentage, DOJ may have a projected \$4.M remaining in unexpended IAT.

### FY 19-20 Personnel/Budget Ratio





# PERFORMANCE INFORMATION

### Over the last five years the Medicaid Fraud Control Unit has:

- Received more than 11,000 complaints of abuse and fraud, resulting in approximately 350 new cases per year, resulting in approximately 92 arrests and 72 convictions per year. Currently, the unit has more than 570 cases open.
- Averaged recoveries of \$84.5 Million per year, or \$1.6 Million in recoveries per staff member per year.
