

VENDOR COMPENSATION

STATE: R.S. 47:306(A)(3) provides for a state rate of 0.935%, with a monthly limit of \$1,500 per dealer regardless of number of outlets in LA

LOCAL: R.S. 47:337.2(B)(3)(e) provides that the payment of vendor compensation by a local taxing authority shall be as provided by local law or ordinance
